In 2013 and 2014, the Foundation contracted with the Colorado Broadcasters Association (CBA) pursuant to its Noncommercial Supporting Announcement (NCSA) program for the production of television and radio commercials promoting registration for ENS, and for broadcast stations throughout Colorado to air the television commercials a total of 1,000 times per month and the radio commercials a total of 4,000 times per month, at a monthly rate of only \$12,000 per month. The Foundation did not contract with the CBA during 2018, but has not terminated the program service. The Foundation is also working to develop a sustaining funding model for for the program service.

The Foundation has published and maintains a website to provide public information regarding 9-1-1 and Emergency Notification Services in Colorado. The website also provides links to pages maintained by or on behalf of Colorado 9-1-1 Authorities for individuals to register their wireless and/or VoIP telephone numbers with Emergency Notification Services. The Foundation did not incur web authoring expenses in 2018. While the purpose of the web site is to provide public education, it also includes a fundraising appeal and a facility for the public to make donations to the Foundation. Public donations are received through the website, which are used to meet Program, Administrative and Fundraising expenses. The Foundation does not consider these donations Program Service Revenues, because the purpose of the website is not used to generate donations but to provide public information. The donations are incidental to that purpose.
