



## Adams County CodeRED Emergency Notification

The CodeRED Emergency Notification System in Adams County is administered through the Adams County Communications Center (ADCOM911). The system is setup to contact home landline phone numbers within the geographical jurisdictions of the City of Bennett, the City of Brighton, Commerce City, the City of Northglenn, Unincorporated Adams County, and the Adams County portion of Strasburg. This system can also send alerts to cell phones, but residents personally need to register their cell phones into the system. Residents must register under the address in which they'd like to receive notifications. Reregistering the same cell phone number under different addresses (i.e. work, school, and home) is also possible.

The CodeRED System will only be activated in an emergency situation where there is a risk of significant harm, an urgent threat, or when a general notification is needed. When such a threat occurs, a brief message will be sent to those who have opted into the system, updating them or instructing them to seek additional information from other sources. Some of the notifications residents might receive relate to missing children or persons, hostage situations, shootings, structure fires, chemical releases, and natural disasters; as well as non-emergency situations like road closures and debris removal instructions after a severe storm.

**NOTE: If you previously signed up with FirstCall, we recommend that you re-register through CodeRED.**

Although this is a functional emergency notification system, it is not intended to be the sole source of emergency notifications. CodeRED can also make no guarantee that every person will receive an emergency notification in every situation since phone lines may be down, cell phones may be turned off, etc. This system should be considered a supplemental notification system, and we encourage all Adams County residents to take ownership of their own preparedness through developing family disaster plans, building 72-hour Emergency Kits, listening to NOAA weather radios, and being aware of their surroundings and weather conditions. ## Independent Local Notification Systems

The following jurisdictions in Adams County support their own independent notification systems:

- **City of Arvada:** Uses the FirstCall System to send out notifications. This system is based in Jefferson County and automatically registers home landlines within the City of Arvada and Westminster boundaries. To get alerts on your cell phone, residents need to register. - **City of Aurora:** Uses the Everbridge Notification System. In this system, residents can choose the communications method they'd prefer: mobile phone, text message, email or all. - **City of Federal Heights:** Uses the FirstCall System to send out notifications. The system automatically uploads home landline numbers within the jurisdiction. To receive cell phone alerts, residents need to register their cell phone numbers at <https://allertregistration.com/adamscountyc>
- **City of Thornton:** Uses the 21<sup>st</sup> Century Target Notification System. This system contacts landlines and cell phones who have opted-in to receive notifications. - **City of Westminster:** Uses the FirstCall System, similar to Arvada. Landlines are automatically added to the notification list, but to receive cell phone alerts, residents need to register. ## **Frequently Asked Questions: ADCOM911 CodeRED System**

- 1) **Which jurisdictions are in the CodeRED ADCOM911 System?**
  - City of Bennett
  - City of Northglenn
  - City of Brighton
  - Unincorporated Adams County
  - Commerce City
  - Strasburg (Adams County residents)
  
- 2) **Do I have to sign up to receive alert calls on my landline at home?**

The system is setup to contact home (landline) phone numbers within Adams County, but it does not alert cell phones unless you are registered. The system is geographically based, so if you want to receive alerts on your cell phone for both your home address and work address, you will have to register the same number twice. - 3) **Will I receive notifications if my landline is registered on a no call/ no soliciting list?**

Yes, you will receive notifications regardless of registration on a no call/ no soliciting list. Phone numbers are pulled from the Century Link and Comcast database and are provided under special contract.
  
- 4) **What if I only have a cell phone number and no landline?**

If you do not have a landline and only a cell phone, you are not automatically in the notification system. You will need to personally register your cell phone if you wish to receive alerts. Registering your cell phone is optional; although, it is recommended to receive important information about emergency situations near work, home, or school. - 5) **What if I just moved into the area?**

If you've just moved into the area, the system refreshes its landline lists every 3 months. After three months, you will most likely be registered in the system; although, this is no guarantee. It is still a good idea to register your number just to be sure.
  
- 6) **If I register my cell phone under my home address, will I receive alerts if an emergency occurs where I work?**

No, you will only receive alerts based on the address your number is registered under. If you'd like to receive alerts based in the area in which you work, you'll need to register your cell phone number again under your work address.
  
- 7) **What sort of notifications or information will I receive?**

Notifications will be based on information from your local Fire Departments, Law Enforcement, Public Safety, and Emergency Management Offices. Alerts will include, but are not limited to, natural disasters, missing persons, shootings, shelter-in-place, evacuations, fires, road closures, etc.
  
- 8) **Do I have a choice over what type of notifications I might receive?**

Yes, the CodeRED system does allow for residents be notified by phone and email.
  
- 9) **Is my personal information (name, number, address) shared with any outside parties?**

No, your information will not be shared or distributed. It will go directly to a secure database which is only accessed by system administrators for emergency notification purposes.
