In 2013 and 2014, the Foundation contracted with the Colorado Broadcasters Association (CBA) pursuant to its Noncommercial Supporting Announcement (NCSA) program for the production of television and radio commercials promoting registration for ENS, and for broadcast stations throughout Colorado to air the television commercials a total of 1,000 times per month and the radio commercials a total of 4,000 times for month, at a monthly rate of only \$12,000 per month. The Foundation did not contract with the CBA during 2015, but has not terminated the program service. During and after 2015 the Foundation prepared and conducted a survey of Colorado 9-1-1 Stakeholders to identify and prioritize messaging, and the Foundation is also working to develop a sustaining funding model for for the program service.

The Foundation has published and maintains a website to provide public information regarding 9-1-1 and Emergency Notification Services in Colorado. The website also provides links to pages maintained by or on behalf of Colorado 9-1-1 Authorities for individuals to register their wireless and/or VoIP telephone numbers with Emergency Notification Services. The Foundation incurred \$13.00 in web authoring expenses. While the purpose of the web site is to provide public education, it also includes a fundraising appeal and a facility for the public to make donations to the Foundation. Public donations are received through the website, which are used to meet Program, Administrative and Fundraising expenses. The Foundation does not consider these donations Program Service Revenues, because the purpose of the website is not used to generate donations but to provide public information. The donations are incidental to that purpose.

**Part VI, Line 4: Changes to Governing Documents.**

The Foundation's Board of Directors approved revised and restated Articles of Incorporation at its 3/13/2015 meeting. Non-substantive changes were made to the statement of purposes to more accurately describe purposes, and eliminate statements which described specific potential programs falling within other statements of purpose. The articles were also amended to (i) permit up to two of the seven Directors to be employees of Public Safety Answering Points ("PSAP") or agencies operating PSAPs ("9-1-1 Directors), (ii) permit up to two of the seven Directors to be employees of for-profit companies providing goods or services to PSAPs ("Industry Directors"), (iii) require that 9-1-1 Directors and Industry Directors recuse themselves from discussion or voting on matters before the Board in which they have a "Direct Interest," (iv) permit a majority of "Independent Directors" (Directors who are not 9-1-1 Directors or Industry Directors) to require that a 9-1-1 or Industry Director recuse himself/herself from discussion and voting on any matter in which the 9-1-1 or Industry Director or his/her employer has a sufficient "Direct Interest" or "General Interest" as to create an appearance of impropriety, (v) require that at least one Independent Director attend a Board Meeting for a quorum to be present, and (vi) provide that at any time at which there are five or fewer Directors on the Board, no more than one 9-1-1 Director and one Industry Director may vote upon matters before the Board. The purpose of these changes is to allow for participation on the Board of Directors of individuals with knowledge, expertise and interest in the purposes of the Foundation to improve the effectiveness of Programs and efficiency of use of Foundation resources; while avoiding actual or apparent conflicts of interest.

This Form 990 and related schedules were prepared by Joseph P. Benkert, a Director and Vice Chair of the Board of Directors. Mr. Benkert provided drafts of the completed form and schedules to each Director for review prior to filing.
